一、课程目的

以联合国为代表的的国际组织是国际关系的重要行为体，为塑造二十世纪以来国际关系的结构和进程发挥了不可替代的重要作用。本课程聚焦国际组织研究理论与国际组织实践，结合国际关系和国际法两个领域的研究，以联合国（包括联合国安理会、联合国大会、世界卫生组织、国际法院）和世界贸易组织为案例，通过深入研读名家经典文献和交叉前沿研究，重点探讨以下议题：

1. 国际组织的历史演变
2. 国际关系理论与国际组织研究
3. 国际组织的法律基础
4. 国际组织的制度设计与内部运作

5. 评估国际组织的多重视角

6. 中国参与国际组织

本课程旨在帮助学生掌握国际组织研究的主要理论、熟悉国际组织研究的分析工具和资料来源。国际组织的创建和运作与国际法息息相关，课程内容涵盖对条约法和国际组织法的介绍和分析，帮助学生建立起对国际组织章程和程序性规则的掌握，深化对国际组织内部运作的理解，思考国际组织政治基础和法律规则及二者之间关系。课程阅读材料遴选自制度主义、建构主义、批判法学、马克思主义等多个理论视角，启发学生对国际关系领域以新自由制度主义为导向的国际组织研究议程进行反思。

二、教学方式

本课程采取教师教授、小组发言和学生讨论相结合的教学方法，由授课教师组织学生对阅读材料进行深入讨论。从第二次课程起，选课学生根据本周阅读材料进行小组发言。课程阅读材料以英文文献为主，所有同学须在课前完成所有必读材料的阅读，并提交3篇读书报告。阅读材料可以通过北大图书馆或者教学网下载。

三、成绩评定

1. 读书报告

每位选课同学须选择3次课的阅读材料（不包括第一次课）提交3篇读书报告。读书报告须归纳阅读材料的研究问题、研究方法和主要结论，并评述阅读材料的

贡献和不足。每篇不超过 2000 字，报告须在上课前提交纸质版和电子版（至教学网），逾期不予接收。每篇读书报告满分 10 分，共计 30 分。

2. 小组报告

小组报告须针对本周阅读材料进行归纳和评述，并提出 3-4 个课堂讨论问题。小组报告 PPT 须在课程当天中午十二点之前发给授课教师和助教，报告时间在 30 分钟左右。小组报告满分 10 分。

3. 期末论文

在课程内容范围内自选一个题目，在 2021 年 1 月 15 日之前提交一篇符合学术规范、注释完整的学术论文，字数（包含摘要和注释）在 10000 字左右，引用注释体例参考《国际政治研究》。期末论文须提交纸质版和电子版。纸质版论文提交至赖华夏老师信箱（国关学院 A 座一楼）。电子版论文提交至教学网。迟交论文每晚一天扣 5 分。期末论文满分 60 分。
